1. The company will provide charterers following equipment:

2. In the hiring period specified in point 1 Included is the time of transfer and return the yacht.

3. **The company** declares that the equipment is insured yacht Casco OC NW /

4. **The company** undertakes to supply the yacht **Charterer** on hours 14.00 - 18.00 at the port in "Piękna Góra" near Giżycko (Port Holdings Fisheries).

Repayment of the yacht on from 8.00 - 11.00.

Yacht charterers give the supernatant, free from damage and defects, able to continue sailing.

5. The fee for day charter is a fixed amount

6. **Charterer** will pay us compensation for the charter of the pre-determined in the following

Second payment on receipt of the boat

Charter price includes: yacht ready to cruise, engine, toilet chemical fluid to a toilet, a bottle of gas for stoves and refrigerators, and optionally the heating system. Non-standard equipment is also included in the price of the basic charter. We do not charge extra fees for a dog on board.

Charter price does not include:

- Final cleaning fee per boat 50 zł
- fuel tax / fuel to the engine "on demand" /.

7. Agreement on the yacht charter is enacted on sending a signed copy and the advance payment within the prescribed period. No payment in a timely manner means giving up the charter.

8. In case of cancellation of the contract by the **Charterer Company** does not return for payments made.

9. On the transfer of the yacht **Charterer's** agent takes a deposit of **500 PLN (five hundred złotych)**. Deposit will be forfeited or settled after the trip. Liquidation minor damage and shortages burden Charterer

10. Required documents for receipt of the yacht:

- a) the charter agreement,
- b) the confirmation of payments made for chartering,
- c) the **Charterer** ID card,
- d) the patent authority to provide yacht

11. **Charterer** is responsible for the yacht and its equipment during the period of the contract, is also responsible for other persons on the yacht.

In the case of damage to qualify for the liquidation of an insurance policy paused after receipt of a deposit account for the Insurance Company to pay compensation. Detailed information is contained in the General Conditions of Insurance Charter.

12. Inappropriate timing of the sentence, the yacht will cruise deduction from the deposit amount for day charter plus 100% or 30 zł per hour of delay.

13. If for various reasons beyond the Charterer, resulting from injury to the yacht, destruction, etc. The charterer cannot get the boat provided for in the agreement, then the obligation of companies to provide the boat with an approximate standard. In the case of sharing the boat with less standard company returns the difference of costs when the boat will provide a higher standard Charterer assumes no extra cost.

14. Matters not covered by the contract will be settled based on the Civil Code by the Court of territorial jurisdiction for the seat of the **Company**.
